Sub: Age Relaxation in the upper age limit in direct recruitment to the post of Mining Sirdar and Overman

Dear Sir,

The issue of age relaxation in the direct recruitment of statutory personnel such as Overman and Mining Sirdar has been raised in various forums to fulfill the statutory requirement of such personnel in the subsidiaries of CIL.

In its 330th meeting held on 19th & 20th July 2016 at CIL (HQ) Kolkata, the Board of Directors of CIL deliberated on the issue and approved as under :

- I. There would be one time relaxation of 5 years in the upper age limit for direct recruitment of Overman and Mining Sirdar categories as given below:

Category	Existing upper Age Limit (Yrs)	Upper age limit after relaxation (Yrs)
Unreserved	30	35
SC/ST	35	40
OBC	33	38

- II. Relaxation is applicable for once and notification to this effect for direct recruitment shall be circulated/published and completed within 1 (one) year.

I have been directed to request you to kindly arrange to take needful action at your end for its proper implementation without any change in the above decision.
