The prospective bidders shall download the tender documents for their reference and attend the Pre-NIT meeting as scheduled above, if they intend to do so and give their representation/ suggestion in writing. The prospective bidders may also send their views/suggestions by post/email to the office of ED/HoD(L&R). (hodlnr.cil@coalindia.in) at least 3 days prior to Pre-NIT meeting.

Such comments / suggestions (on any/all aspect of the document) may be suitably incorporated, if found necessary, and bid document be drafted. Bids be invited thereafter as per standard practice. However, CIL reserves the right to agree or disagree in the interest of the company.

The prospective bidders should not upload any tender documents on the portal.

Prospective Bidders are requested to kindly provide the following at the time of Pre-NIT Meeting:

1. Budgetary offer, along with detailed breakup for the scope of work;
2. Requirement of man-days - along with qualifications;
3. Methodology of deriving estimated cost for the consultancy job;
4. Milestones and payment schedule

Non-attendance in the pre-NIT meeting will not be a cause for disallowing of the bidder in bidding.

NOTE: Bidder shall not submit their bid. This is for Pre-NIT meeting ONLY!

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
