1. Introduction

This Expression of Interest (EoI) is being floated by Coal India Limited for the purpose of identifying Latest Technology in Desktops/Work Stations/ Thin Clients from OEMs who are willing to participate in procurement of Desktop PCs/Workstations/Thin clients and Multi Functional printers for Coal India Ltd's Headquarter at Kolkata with robust, cost effective and scalable technology options.

The objective of this Expression of Interest (EoI) is to identify efficient solutions with a clear understanding of the scope, approach and technical architecture & other technical conditions as per the requirement of Coal India Ltd for a period of five (5) years.

2. Project Background

Coal India Ltd's Headquarter at Kolkata is going to procure some desktops / Workstations/Thin Clients through GeM with optimum feasible Technology solutions from OEMs to run SAP/CoalNet, Web applications, Antivirus for client, Power BI used by few users, AutoCAD for Project Monitoring department, Microsoft Office and Web portals.

3. Objectives of Eol

The following are the objectives of the EOI for procuring some Desktops / Workstations/Thin Clients and Multi Functional printers through GeM for Coal India Ltd's Headquarter at Kolkata:

- i. Prospective OEMs can propose Technical feasible solution for procurement of desktops / Workstations/Thin Clients and Multi Functional printers through GeM
- ii. OEMs may submit their interest along with the technical proposal.
- iii. No commercial offer should be provided with this EOI.
- iv. Obtain confirmation as to how the service providers/system integrators/OEMs would technologically, operationally provide and support these services.
- v. OEMs should provide their expression of Interest along with the technical proposal. The technical proposal should include complete details by complying minimum specifications (as mentioned in scope of work) of Desktops/Work Stations/ Thin Clients and Multi Functional printers. It should be submitted with supportive documents with justification and reasons for accepting or not accepting any of the categories Desktops/Work Stations/ Thin Clients MFP to run SAP/CoalNet, Web applications, Antivirus for client, Power BI used by 6 employees, AutoCAD for Project Monitoring department, Microsoft Office and Web portals.

- vi. The minimum required specifications for the proposed solution/infrastructure are mentioned in Scope of Work. If OEM feels that any of specification is inadequate, they can add/modify on with remarks and supporting document.
- vii. OEMs should confirm compliance with each of the specifications/ in the respective columns with documentation (if any) to support the same.
