OFFICE ORDER

In pursuance of Department of Personnel & Training (DoPT), MPPG&P, GoI, OMs dt. 19.01.2019 and dt. 31.01.2019 regarding reservation for Economically Weaker Sections (EWSs) in direct recruitment in Civil posts and services in the Government of India, the Competent Authority approved the following :

1. Inclusion of the following clause in the offer of appointment issued to the candidates claiming to be belonging to EWS:

“the appointment is provisional and is subject to the Income and assets certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake /false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate”

2. Sri Chinmaynanda Gupta, Sr. Manager (P/R) (9433007264) is nominated as the Grievance Redressal Officer for Coal India Limited Hq, Kolkata.
3. Ms. Sugandha Verma, Dy. Manager (P/R) is nominated as the Liaison Officer for Coal India Limited Hq, Kolkata, to monitor the implementation of reservation for EWSs.
