

Their promotion/selection to Officer (Survey) in E-1 Grade will abide by finality / outcome of the MAT no.238 of 2022 with CAN No. 1 of 2022, Supriya Gangopadhyay & Ors Vs CIL & Ors.

On promotion / selection to the post of Officer (Survey), the above employees will be governed by the Conduct, Discipline and Appeal Rules - 1978 of CIL, as amended from time to time and their service conditions will be same as applicable to the Executive Cadre employees of Coal India Limited and its Subsidiary Companies.
