**Subject: Change of mode of dispatch from Rail to Road for the consumers of Linkage Auction for non-regulated sector and Special Forward/Exclusive E-Auction**

Vide letter no. CIL/M&S/Linkage auction/494 dated 25<sup>th</sup> July 2017 coal companies were communicated about the dispensation for change of mode of despatch from Rail to Road, given for Non-regulated sector consumers coming through Linkage auction for the period of 90 days along with its operative modalities.

Similar dispensation was also extended to Special Forward & Exclusive E-auction consumers and the coal companies were communicated about the dispensation along with its modalities vide letter no. CIL/M&S/E-Auction/519 dated 01<sup>st</sup> August 2017 and subsequent clarification letter no. CIL/M&S/e-auction/624 dated 14.09.2017.

In view of current arrear rake position, CIL Board in its 350<sup>th</sup> meeting held on 11.11.2017 accorded its approval for the following:

- Continuation of dispensation of change of mode of supply from Rail to Road to the consumers of non-regulated sectors through Linkage Auction route for rest of the fiscal 2017-18 with similar modalities as given to them earlier.
- Continuation of similar dispensation of change of mode of supply from Rail to Road to the consumers of Special Forward & Exclusive e-Auction for rest of the fiscal 2017-18 with similar modalities as granted earlier.
- Subsidiary coal companies are authorized for taking decision for extending such dispensation to the above categories of consumers under 'ease of doing business' for liquidation of arrear rakes.

You are, therefore, requested to take further necessary action at your end for implementing such dispensation.
