
In lines of the same, the following penal measures are imposed with immediate effect from date of issue of this letter:

3. Forbidding your agency and partners (Smt. Nidhi Paul, Shri Surajit Basu, and Shri Abir Kundu) from participating in retender process and debaring them for a minimum period of 12 (twelve) months from participating in future tenders with Coal India Limited, Kolkata.
