During the meeting held by Hon'ble MOS(IC) for Power, Coal and New & Renewal Energy on 20.06.2014 & 19.08.2014 with the representatives of MOC, MOP, CEA, CIL & Association of Power Producers; it was agreed that in addition to the agency engaged by CIL, an independent third party sampling agency can be deployed by PUs/ Power producers from their end. A Standard Operating Procedure (SOP) was accordingly circulated and placed in the web-site for the purpose.

Subsequently due to operational issues said SOP was reviewed, modified and duly approved by CIL Board vide its minutes of 314th meeting held on 12th May 2015. The consequential changes in the applicable model FSA is hoisted in our Website {link "Our Business" - "Sales & Marketing"- NCDP-FSA- Documents - under heading - Modification of FSA provisions for incorporating Third Part Sampling and analysis arrangement post 314th CIL Board Decision}. The headline may be read as "Modification of FSA provisions for incorporating Third Party Sampling and analysis arrangement by PUs/ IPPs."

It is clarified that modified provisions with regard to Sample collection, Sample preparation and analysis, detailed modalities for third party sampling, preparation of collected samples hoisted vide aforesaid link & PDF file, have been evolved on the basis of model FSAs applicable for new TPS. However, the provisions shall also be applicable to other PUs/ IPPs who were accorded third party sampling facilities by CIL earlier.
