No. 03/2022 of CIL for Recruitment of Management Trainee through Computer Based Test (CBT), are hereby informed that they have been **PROVISIONALLY SELECTED** for the said post and will be required to report for Documents Verification (DV) and Initial Medical Examination (IME) at the allocated Subsidiary on **27<sup>th</sup> March, 2023**.

Please note that the issuance of final Offer of Appointment (OOA) in CIL will be subject to candidate being declared successful in the DV and IME.

In case any candidate fails to report for DV & IME at the concerned allocated Subsidiary on the scheduled date, his/her candidature will stand cancelled automatically, without any further notice to him/her.

It may further be noted that in case the candidate fails to produce the required document/s on the date of DV, he/she will not be allowed to appear in IME and his/her candidature will stand cancelled immediately without any further notice.

Further, if the candidate fails to meet the prescribed Medical Standards in IME as per Medical Attendance Rules (MAR) of CIL and is declared "Unfit for Employment" in CIL, then also his/her candidature will be cancelled accordingly.

7.	15 Copies of recent passport size colour photograph, as pasted in the Application Form.
8.	Matriculation / 10 <sup>th</sup> / Secondary Board Level Certificate / Marksheet / Admit Card where date of birth is clearly mentioned/specified.
9.	Marksheet of HSC / 12 <sup>th</sup> Standard.
10.	Final Degree and Semester-wise Marksheets as required for minimum eligibility criteria specified in Advt. No. 03/2022 (Percentage of marks obtained should be clearly visible in the Certificates).
11.	For candidates of Personnel/HR, Marketing & Sales, Community Development etc., discipline, the specialization in the relevant field and/or Major specialization, as specified in the advertisement, is mandatory and it should be clearly mentioned in the Degree / Certificate / Marksheets. In case of not meeting the minimum eligibility criteria, the candidature for the post of MT will be cancelled without giving any further chance.
12.	CGPA/GPA, conversion in Percentage (%) certificate issued by University/Institute, if applicable.
13.	For OBC (Non-Creamy Layer), SC / ST - Valid Caste Certificate in prescribed format issued by Competent authority, already available on CIL Website.
14.	For PwD category - Certificate mentioning the Category/Sub-Category of the benchmark disabilities, as notified in the Advertisement No. 03/2022 in the prescribed format of Govt. of India duly issued by the Competent Authority, already available on CIL Website. Non-submission of the said certificate will attract rejection of candidature.
15.	For Economically Weaker Sections (EWS) – Those candidates who have applied under Economically Weaker Sections (EWS) category will have to submit a copy of Valid Income & Asset certificate issued by the competent authority as per OM No. 36039/1/2019-Estt (Res) dated 31.01.19 of DoPT, Ministry of PPG&P, Govt. of India on the basis of gross annual income of Financial Year 2021-2022. Non-submission of the EWS certificate will attract rejection of candidature.
16.	No Objection Certificate (NOC) from the present employer if employed in Government / Semi-Govt. / Public Sector Undertaking / Autonomous body. <b>“NOC” is mandatory and its non-submission will attract rejection of candidature.</b>
