ORDER

In pursuance of letter No21/27/2021-ESTABLISHMENT dated 22.11.2022 from Under Secretary to the Govt. of India, Ministry of Coal, New Delhi conveying the approval of the President and in pursuance of Articles of Association of Coal India Limited (CIL), Shri Mukesh Choudhary, Director, Ministry of Coal has been appointed as Director (Marketing), Coal India Limited (CIL) in Schedule 'A' of the CPSE, on immediate absorption basis in the scale of pay of Rs.1,80,000-3,40,000 for a period of five years with effect from the date of his assumption of charge of the post or until further orders, whichever is earlier subject to the condition that after the expiry of the first year, the performance of Shri Choudhary will be reviewed to enable the Government to take a view regarding continuance or otherwise for the balance period of tenure.


His appointment to the said post will be effective from the date on which Shri Choudhary takes over charge of the said post. However, his appointment as Director (Marketing), CIL for the said period is made on contract basis and the Government will have the option to terminate his services with three months' notice or with three months' pay in lieu thereof.

As stipulated in DPE's O.M. No. 18(21)/98-GM-GL-73 dated 20th October, 2005, if Shri Choudhary does not join the post he shall be debarred for a period of two years from the date of offer of appointment, from being considered for Board Level posts in any CPSE. The debarment would be applicable to all CPSE's other than the one to which the candidate belongs.

Detailed terms and conditions of appointment of Shri Choudhary as Director (Marketing), CIL will be issued in due course of time after receipt of his Last Pay Certificate (LPC).

The appointment of Shri Mukesh Choudhary is subject to the final outcome of WP(S) No.10800/2019 in the High Court of Chhattisgarh.

Shri Mukesh Choudhary will assume the charge of the post of Director (Marketing), CIL in Schedule 'A' of CPSE in the pay of Rs. 1,80,000-3,40,000/- and submit his joining report to Chairman-cum-Managing Director, Coal India Limited, under intimation to Ministry of Coal.
