विषय: Amendment to Clause-8.9.5 of Purchase Manual, 2020

The Clause-8.9.5 of CIL's Purchase Manual 2020 is amended as follows, effective from **15th May 2020**:

- “a. **Global Tender Enquiry (GTE):** Where it is felt that the goods of the required quality, specifications, etc., may not be available in the country and it is necessary to look for suitable competitive offers from abroad, Global Tender Enquiry may be issued. In such cases besides the usual publicity as in case of Advertised Tender Enquiry, the copies of the tender notice may be sent to the Foreign Embassies in India as well as to the Indian Embassies abroad requesting them to give wide publicity of the requirement in those countries including hosting the tender notice on their web sites. The selection of the embassies will depend on the possibility of availability of the required goods in such countries.
- b. No Global Tender Enquiry (GTE), however, shall be invited for tenders up to Rs. 200 crores or such limit as may be prescribed from time to time. Provided that for tenders below such limit, in exceptional cases, where it is felt by the procuring entity that there are special reasons for GTE, it may record its detailed justification and seek prior approval for relaxation to the above rule from the Competent Authority.”

The Competent Authority for relaxation as brought out at 'b' above will be Functional Directors of Subsidiaries / CIL.

The above amendment is applicable for all the tenders published in newspapers or website **after 15th May 2020**.
